INGREDIENTS	Refined mineral and chemical additives – determined to be not hazardous
PHYSICAL DATA	Density @ 15°C 0.896 Flash Point °C Typical > 102°C Viscosity cSt @ 100°C 8.1
FIRE AND EXPLOSION HAZARD DATA:	Flash point over 170°C. Will not burn unless heated to high temperatures. Extinguish fires with CO2, Dry Chemical, Foam or BCF.
